



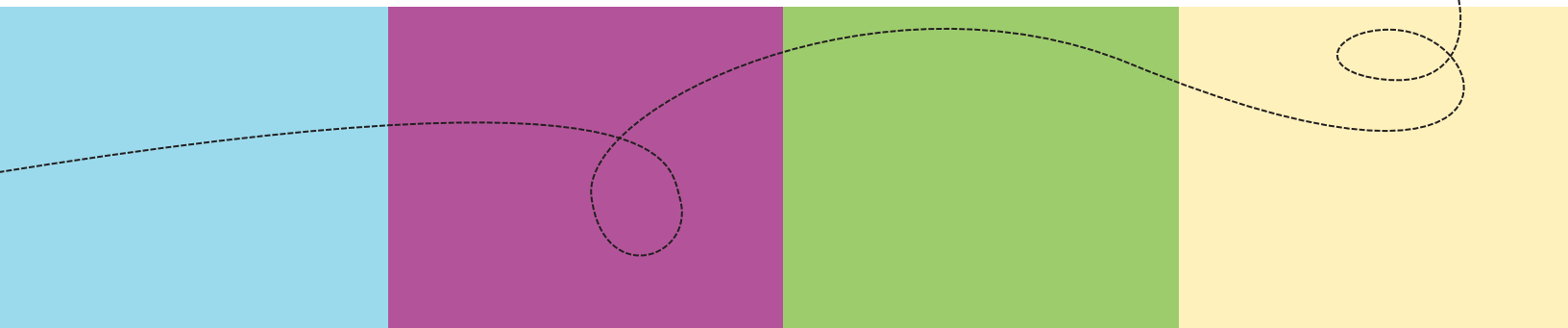

Letter from the President



On behalf of the Board of Directors, I would like to thank all of Isabel's House's staff, volunteers, and donors. Through your hard work and generosity Isabel's House nears its 10th anniversary of serving a vital role in Springfield and the surrounding area. You have provided a safe, judgement-free place for families in crisis to entrust with the care of their children, giving them the time and resources they need to work through their immediate needs. Having cared for more than 3,550 children from over 1,750 families you have allowed hundreds of families to stay

together that might not have otherwise been able to do so. In fiscal year 2015-2016 alone the House cared for 360 children of 186 families with 94% of those families being able to work through their time of need and ultimately remain together as a family.

The success of the House in keeping families together would not be possible if not for the staff and volunteers that care for the children in our care. This amazing group of people work tirelessly to ensure that the children are cared for with as little interruption to the child and family's life as possible.

Being open 24/7 365 days a year is no easy task, and this year the staff and volunteers stayed busy spreading the word that our doors are ALWAYS open when help is needed, as well as raising funds to help provide care to the children and families in need. Whether it was our Isabel's Tree Lighting Party, Hooray for Hollywood (our signature event), participation in numerous events during April's Child Abuse and Neglect Prevention Month, participation in the Community Foundation's #GiveOzarks campaign or THE Summer Party, you didn't have to look far to find staff members and volunteers working hard to raise community awareness and raise the funds needed to continue serving our community.

In recognition of what the staff and volunteers of Isabel's House have done and will continue to do for our community, the Springfield Business Journal named Isabel's House as their Charitable Nonprofit of the Year during its 2016 Economic Impact Awards recognition event.

As the House nears its 10th anniversary, a committee of staff and volunteers has been formed to plan for the next 10 years. With the House being at near capacity, a continued need to provide a safe place for children of families in crisis, and evolving other needs of the community, I'm sure the staff, volunteers and donors will rise to the occasion and help Isabel's House continue to fill a vital role in our community.

Again, thank you to all that have helped Isabel's House put smiles on children faces and keep families together.



Isabel's House is making a difference in our community by providing families with the resources they need to strengthen their families and prevent child abuse and neglect.

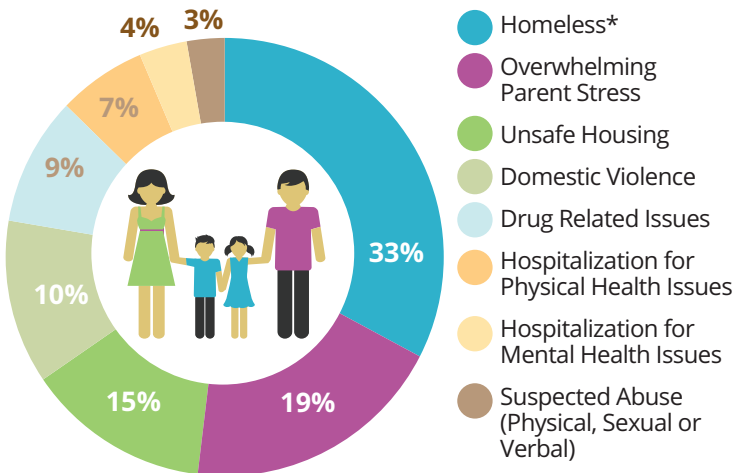

2015-16 PRIMARY REASONS FOR SERVICE

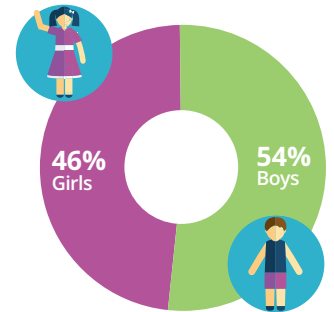
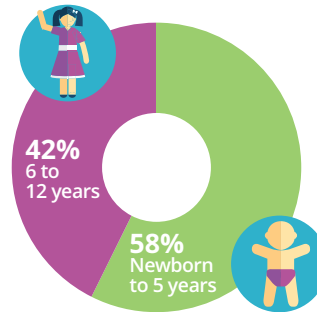


*In Springfield, more than 800 kids started the 2015-16 school year homeless or at risk of homelessness.

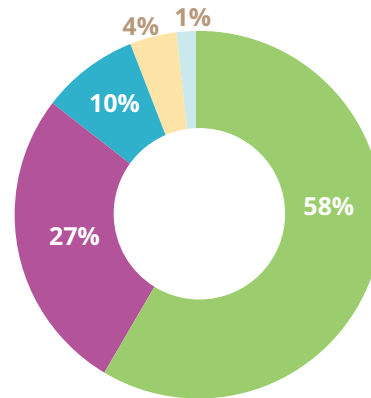
In Missouri, a child is abused or neglected every two hours



AGE AND GENDER 2015-16



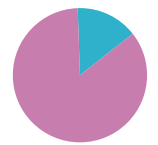
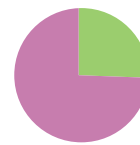
ETHNICITY 2015-16

Economic Impact Award

Isabel's House was honored to be nominated by readers and chosen by an independent panel of judges to receive Springfield Business Journal's "Charitable Nonprofit of the Year" honor during its 17th annual Economic Impact Awards. This honor is only awarded to nonprofit organizations actively working in our community but that do not charge for services. As part of our ongoing mission to care for kids, strengthen families, and prevent child abuse and neglect, no family will ever be asked to pay to use the services provided by Isabel's House.

In an interview with SBJ, Holly Beadle, Executive Director, reiterated the economic implications of our mission while emphasizing that "we meet families where they are." With 98% of the families served by Isabel's House living at or below the federal poverty line, our capability to offer support for families at no cost to parents is vital. Holly and SBJ writers were also careful to emphasize the long-term costs of child abuse and neglect on our local community, citing CDC statistics which reveal an average lifetime cost for each child of over \$210,000. "When you look at the economic impact of child abuse and neglect on our community – what the financial cost is and more importantly the children who grow into adults – that is huge," Holly noted, while the cost to meet a child's essential needs for an average stay at Isabel's House – about \$1,500 – remains low, by comparison.

While the reasons to say "thank you" to our loyal donors is countless, receiving an SBJ Economic Impact Award prompts the staff and Board at Isabel's House to double-down on gratitude. Thank you for choosing to invest in better outcomes for children in our community. Thank you for being a part of our economic impact, this year and every year.

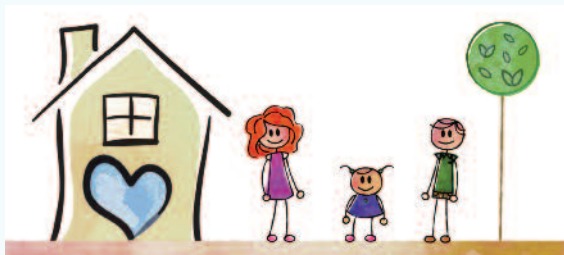
